4. Action Items

a. <u>Discussion/Motion- Conditional Use Permit request for Sam Howard for an oversized structure totaling 1,800 sq. ft. located at 5910 S 6300 W.</u>

The City Planner, Malcolm Jenkins, presented Sam Howard's request for a conditional use permit for an oversized structure. The structure meets height requirements and is for hobby, woodworking, and storage use, with plumbing and electricity. The rear setback is 5 feet, requiring either adjustment or easement abandonment due to a 10-foot public utility easement. Staff recommends approval conditions on meeting one of two conditions: moving the structure 5 feet forward or completing the easement abandonment process.

Sam Howard – Applicant

Sam Howard addressed questions, indicating willingness to move the structure if needed but will apply to get the easement abandoned.
