- 2. Seek the services of a collection agency for all delinquent charges and any fees imposed.
- 3. File a Property Tax Lien with the Weber County Treasurer's Office for all delinquent charges and any fees imposed. All laws applicable to the levy, collection and enforcement of the city real estate property taxes shall be applicable to such an assessment.
