Rules Governing the Use of Fields

Advertising

The posting of advertisements for any products or services is not permitted.

Alcohol & Smoking

Alcohol, Smoking, Vaping or use of Electronic Cigarettes are not permitted on Hooper City property.

Application Processing

Applying should not be considered an approved permit. All permits must be processed and signed by an authorized Hooper City representative and are valid only on the dates and times shown.

Certificate of Insurance

A Certificate of Insurance naming the Hooper City as "additional insured" is required from all organizations with minimum liability coverage of \$1,000,000. Applications will not be accepted without this certificate.

Damages and Responsibility

The renter agrees to be responsible for any damage to the field, facilities, or equipment that occurs during the rental period. Any damage, whether accidental or intentional, must be reported to Hooper City immediately. The renter will be held financially liable for the cost of repairs, replacements, or cleanup resulting from such damages. Failure to report or cover damages may result in additional fees and could affect future rental privileges.

Equipment

Groups and individuals renting sports fields must bring their own equipment for use on the fields. Hooper City does not supply items including but not limited to: soccer nets, baseball/softball bases. Any injuries sustained by individuals at the time of the rental using their own, or other participants' equipment, will be the responsibility of the renter (see Certificate of Insurance). You are the renter are also responsible for removing the equipment off the field after each rental due to other rentals that take place.

Fields

Renters of athletic fields are not allowed to apply any paint, chalk or similar material with the intention of installing lines, boundaries or logos without permission from Hooper City.

Refunds

User groups will not be issued refunds for cancellations. Credit for another date will be given if cancellations are done with at least 72 hours' notice. No refunds for unused credit. Weather-related cancellations and credits can only be authorized by Hooper City.

Vehicles

Absolutely no vehicles are allowed on the fields or City private access ways. Violators are subject to being ticketed by the Weber County Sheriff's Department and will lose all future approval. No exceptions. The city does not have the authority to allow parking on facilities (church parking lots, private property, etc..) owned by others.

Weather Conditions

The City reserves the right to cancel any rental or restrict access to fields due to severe weather, poor playing conditions or poor field conditions due to weather.

Water Irrigation Schedule

The renter understands that the irrigation system operates on a pre-set schedule managed by Hooper City. This watering schedule is necessary to maintain the health of the grass and cannot be altered or adjusted to accommodate rental times or events. Renters are encouraged to plan their activities accordingly, as irrigation may occur before, during, or after scheduled use. Hooper City is not responsible for any inconvenience caused by irrigation cycles.

Wavier for Field Rentals

I/We, the undersigned, hereby certify that I am/we are the sponsor(s) or appointed representatives of the organization requesting use of the field. I/we will be responsible for the conduct and personal injury of all people in attendance at the field stated above. I/We hereby assume liability for any injuries, damages, or loss to the field, equipment, and/or Hooper City personnel or representatives during this time and place. It is fully understood and agreed to by all parties that the sponsoring organization guarantees to indemnify and hold harmless Hooper City, its public officials, employees, volunteers and agents against any and all suits of any manner which might arise as a result of the covered activities and that the sponsoring organization agrees to defend said Hooper City, its public officials, employees, volunteers and agents and indemnify same against any and all expenses incurred in the defense of any suit of any type arising out of the covered activity or any damages, judgments or decree which might be awarded against said City in the event that the suit should be brought as the result of the covered activity(ies), including transportation services as identified above. I have read the general rules and regulations, and I understand that failure to comply with any or all rules will result in revocation of use request and damage deposit and may also result in refusal of future use.

I have read the rules governing the use of Hooper City facilities and agree that the organization using the requested sports field on the above dates and times will abide by them.
